LOCAL LAW AMENDING THE TOWN OF GEDDES TOWN CODE SECTIONS 220-2 (STOP INTERSECTIONS) 220-3 (THREE-WAY STOP INTERSECTIONS) 220-4 (FOUR WAY STOP INTERSECTIONS) BY STRIKING THE REFERENCE IN SECTION 220-4 TO A FOUR WAY STOP INTERSECTION AT FAY ROAD WESTMONT ROAD AND CORY ROAD AND ADDING A NEW STOP INTERSECTION AT WESTMONT ROAD AND FAY ROAD AND A NEW THREE WAY STOP INTERSECTION AT FAY ROAD AND CORY ROAD

#### BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF GEDDES AS FOLLOWS:

**Section I:** The Town of Geddes Town Code, being Local Law No. 1 of 2001, as has previously been amended, is hereby further amended at §220-2 (Stop Intersections), §220-3 (Three-Way Stop Intersections), and §220-4 (Four Way Stop Intersections) by striking and removing the reference in §220-4 to a four way stop intersection entitled: "Fay Road at Westmont Road, Westmont Road at Fay Road and East Corey Road at Fay Road", and adding a new Stop Intersection at Westmont Road at Fay Road in §220-2, and a new Three Way Stop Intersection at Fay Road and Cory Road in § 220-3; said amendments shall read as follows:

### "§ 220-4 Four Way Stop Intersections.

The following named intersections are hereby designated four-way stop intersections, and all vehicles approaching said intersections from any direction shall, before entering the intersections, come to a full stop unless otherwise directed by a police officer or signal:

#### Intersection

Fay Road at Westmont Road, Westmont Road at Fay Road and East Corey Road at Fay Road";

## § 220-2 Stop Intersections.

The following named intersections are hereby designated as stop intersections, and all vehicles on each street enumerated in the first column below shall come to a full stop before entering the street opposite thereto in the second column below, namely:

Vehicles On Shall Stop Before Entering

Westmont Road Fay Road;

### § 220-3 Three Way Stop Intersections.

The following named intersections are hereby designated four-way stop intersections, and all vehicles approaching said intersections from any direction shall, before entering the intersections, come to a full stop unless otherwise directed by a police officer or signal:

# Intersection

Fay Road at Corey Road"

**Section II:** Local Law No.: <u>1 of 2001</u>, as amended, is further amended as specified hereinabove.

**Section III:** This local law shall take effect immediately upon posting and publication as required by law and filing with the Secretary of State.
