An Emergency Ordinance to Amend §92-4 Designation of Gold Room Assistance

WHEREAS, the City of Glenarden is a municipal corporation of the State of Maryland, and operating under Article XI-E of the Constitution of Maryland and §5-202 of the Annotated Code of Maryland as amended; and

WHEREAS, the Glenarden City Council designated the Gold Room as an enterprise zone; and

WHEREAS, §92-4 allows the City Council to designate a person as assistance to the City Manager in the operation of the Gold Room; and

WHEREAS, the Gold Room should be able to operate without interruption; and

WHEREAS, the City Council feels that in order to do this Section 92-4 of the City Code needs to be clarified.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of Glenarden, Maryland sitting in Regular Session this 11th day of April, 2022 that:

1. Chapter 92, § 92-4 Designation of Gold Room Assistance be and is hereby amended to read as follows:

§ 92-4 Designation of Gold Room Assistance.

The Council may, from time to time, designate a person or persons as assistance to the City Manager in the administration of the use and operation of the Gold Room. The person or persons so designated shall be responsible to the City Manager and serve at the pleasure of the City Council.

BE IT FURTHER RESOLVED AND ORDAINED by the City Council of Glenarden, Maryland that this Ordinance is and shall become effective immediately following approval by the Mayor or passage by the Council over the Mayor's veto.






