#### **ORDINANCE NO. 2088**

AN ORDINANCE OF THE CITY COUNCIL ADDING SECTION 5.40.110 "DELEGATION OF ADMINISTRATION" TO CHAPTER 5.40 "GLENDORA VILLAGE BUSINESS DISTRICT," AND AMENDING SECTION 2.18.050 "APPOINTMENT" OF CHAPTER 2.18 "CITY BOARDS AND COMMISSIONS" OF THE GLENDORA MUNICIPAL CODE

# THE CITY COUNCIL City of Glendora, California

**WHEREAS**, in 2009, the Glendora Village Business Association requested that the City of Glendora initiate proceedings to form a Business Improvement District as permitted under the Parking and Business Improvement Area Law of 1989 (California Streets and Highway Code Section 36500 *et seq.*); and

**WHEREAS**, on July 28, 2009, the Glendora City Council adopted Ordinance 1922 adding Chapter 5.40 to the Glendora Municipal Code (GMC) and establishing the Glendora Village Business District (GVBD), as provided by the Parking and Business Improvement Area Law of 1989 (California Streets and Highway Code Section 36500 *et seq.*); and

**WHEREAS**, the By-Laws of the GVBD state that its purpose is to assist the City of Glendora in the promotion of the physical and financial health of the Glendora Village as a means of providing tax revenues, and physical, economic, and social stability to the City of Glendora at large; and

**WHEREAS**, for the past fifteen years, the GVBD has executed its mission by contributing to improving the appearance of the Glendora Village, promoting and advertising through a range of media outlets, coordinating communications among the GVBD businesses, and sponsoring annual events within the Glendora Village, including the Holiday Stroll and Wine Walk; and

**WHEREAS**, the Glendora City Council has determined that it is in the best interest of the City and the GVBD to allow for the City of Glendora to delegate the administration of the Glendora Village Business District to a non-profit entity who shall implement the improvements, maintenance, and activities of the Glendora Village Business District; and

**WHEREAS**, the Glendora City Council desires to grant the GVBD advisory board the authority to recommend board appointments to the City Council.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GLENDORA, CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:

**SECTION 1**. A new section shall be added to Chapter 5.40 of the GMC, which shall be entitled "Delegation of Administration" which shall read as follows:

"Chapter 5.40.110 Delegation of Administration. The City Council may authorize a non-profit organization to administer the district funds and to operate the improvements and activities of the district as set forth in this chapter. The authorized non-profit organization shall formally report to the city council at least annually, beginning no later than July 1, 2025."

**SECTION 2**. A new subsection to Section 2.18.050(a) "Appointment" is hereby added to the Glendora Municipal Code to read as follows:

"(2) With respect to the Glendora Village Business District, the Business District advisory board shall recommend members for appointment with the consent of the city council as required by state law. The Business District bylaws shall prescribe the process by which board members are selected for appointment."

**SECTION 3.** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining portions of this Ordinance shall nonetheless remain in full force and effect. The City Council hereby declares that it would have adopted this Ordinance irrespective of the invalidity of any particular portion thereof.

**SECTION 4**. If any section, subsection, sentence, clause, phrase, or portion of this Ordinance is for any reason held to be invalid or unenforceable by a court of competent jurisdiction, the remaining portions of this Ordinance shall nonetheless remain in full force and effect.

**SECTION 5**. The Mayor shall sign this Ordinance and the City Clerk shall attest and certify to the passage and adoption thereof and cause same to be published at least once in the San Gabriel Valley Examiner, a weekly newspaper of general circulation, published in the City of Glendora, which newspaper is hereby designated for that purpose (GC Cal. Govt. Code § 40806). This Ordinance shall be effective on the thirtieth (30th) day after its adoption by the City Council.
