RESOLUTION ADOPTING A LOCAL LAW AMENDING SECTION 285-29.2 OF THE CODE OF THE TOWN OF GREENBURGH, ENTITLED "HC HARTSDALE CENTER," AS IT RELATES TO THE COMPOSITION OF HARTSDALE CONTEXTUAL REVIEW COMMITTEE

WHEREAS, the Town Board of the Town of Greenburgh finds it in the best interest of the Town to amend Section 285-29.2 of the Code of the Town of Greenburgh to update the composition and number of members which would constitute the Hartsdale Contextual Review Committee ("HCRC"); and

WHEREAS, a local law was prepared by Town staff, based upon input from members of the HCRC; and

WHEREAS, Section 285-64 of the Zoning Ordinance requires that the Town Board refer proposed Zoning Text amendments to the Planning Board for a report and recommendation before a public hearing is held on an amendment by the Town Board; and

WHEREAS, on January 11, 2023, the Town Board adopted Resolution CD-1 – 1/11/2023, referring the Zoning Text amendment to the Planning Board for report and recommendation; and

WHEREAS, the Planning Board, at a regularly scheduled work session meeting on February 1, 2023, discussed the Zoning Text amendment and on February 1, 2023, made a positive recommendation to the Town Board associated with the proposed Zoning Text amendment, and issued a related report; and

WHEREAS, on March 8, 2023, the Town Board of the Town of Greenburgh held a duly noticed public hearing on the proposed Zoning Text amendment; and

WHEREAS, pursuant to Section 617.5(c)(33) of the SEQRA Regulations, the proposed modification of the composition of members on the HCRC is a Type 2 action under SEQRA, requiring no environmental review;

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Greenburgh hereby adopts the attached Local Law, entitled "HC Hartsdale Center."

§ 1. Title.

This law amending Chapter 285-29.2 of the Code of the Town of Greenburgh, is entitled, "HC Hartsdale Center."

§ 2. Legislative Findings and Intent.

The Town Board of the Town of Greenburgh finds it in the best interest of the Town to amend Chapter 285-29.2 of the Code of the Town of Greenburgh to update the number of members which would constitute the Hartsdale Contextual Review Committee.

§ 3. Amendments to Chapter 285-29.2.

Chapter 285-29.2 of the Code of the Town of Greenburgh is hereby amended as follows (deleted text in strikeout; new text underlined):

§ 285-29.2. HC Hartsdale Center District

- G. Design review.
- (3) The Hartsdale Contextual Review Committee (HCRC) shall be established as follows:
 - (a) The HCRC shall consist of nine-seven members who shall be residents of the unincorporated area of the Town and shall be appointed by the Town Board. Each member shall be appointed for a two-year term, except that five initial appointees shall be appointed for one-year terms so that the terms shall thereafter be staggered. Vacancies on the HCRC

shall be filled in the same manner as for any other appointee, except that the replacement shall serve only for the unexpired term. Members of the HCRC shall include:

- [1] One member of the Town Board;
- [2] The Chair of the Planning Board or chosen designee from that Board;
- [3] The Building Inspector or chosen designee from the Building Department;
- [4] The Planning Commissioner or chosen designee from the Department of Community Development and Conservation; and
- [5] Five Three of the following: residents or members of community associations from the East Hartsdale Avenue area, initially two of whom shall be members from the Hartsdale Hamlet Steering Committee that prepared the Hartsdale Village Streetscape Study. One member shall be a tenant, and one member shall be and a landlord from within the East Hartsdale Avenue area. The tenant shall not be of the landlord if named to the HCRC. A resident from the East Hartsdale Avenue area;
- [6] A tenant from the East Hartsdale Avenue area who is not the landlord representative; and
- [7] A landlord from the East Hartsdale Avenue area.

§ 4. Supersession:

Pursuant to New York Municipal Home Rule Law Section 22, this law is intended to supersede any other inconsistent provision of law.

§ 5. Severability:

If any clause, sentence, paragraph, subdivision, section or part of this law or the application to any person or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law, or its application to the person or circumstance directly involved in the controversy in which such order or judgment shall be rendered.
