**ORDINANCE AMENDING CHAPTER 5-42 OF THE GREENWICH
TOWNSHIP CODE TO INCREASE THE NUMBER OF MEMBERS TO SERVE ON
THE SPECIAL EVENTS AND ACTIVITIES COMMITTEE
WITHIN THE TOWNSHIP OF GREENWICH
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

WHEREAS, Chapter 5-42 of the Greenwich Township Code establishes the Special Events and Activities Committee within the Division of Recreation in the Township of Greenwich; and

WHEREAS, the Mayor and Council wish to amend Chapter 5-42 of the Greenwich Township Code to increase the number of members to serve on the Special Events and Activities Committee; and

WHEREAS, the Mayor and Council have determined that it is in the best interest of the citizens of the Township of Greenwich for the membership on this committees to be increased to properly manage the Special Events taking place within the Township of Greenwich; and

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Greenwich, Gloucester County, New Jersey that the Greenwich Township Code is hereby amended as follows:

SECTION 1.

§5-42 B Special Events and Activities Committee shall be amended as follows:

(2) Membership. Shall be repealed and replaced with the following:

(2) Membership. The Special Events and Activities Committee shall consist of ten (10) members, nine (9) of whom shall be residents of the Township and one (1) of whom shall be a member of the Township Council. The Mayor shall designate one (1) member of the Committee to serve as Coordinator and one (1) member to serve as Secretary.

SECTION 2. All other provisions of Chapter 5-42 are ratified as originally adopted and shall remain in full effect.

BE IT FINALLY ORDAINED that this Ordinance shall take effect twenty (20) days final after final passage and publication as required by law.
