**ORDINANCE AMENDING ORDINANCE 3-2023 ESTABLISHING
THE SALARIES AND COMPENSATION OF THE VARIOUS OFFICERS AND
EMPLOYEES OF THE TOWNSHIP OF GREENWICH
FOR THE CALENDAR YEAR 2022**

WHEREAS, Ordinance 3-2023 establishing the salaries and compensation of the various officers and employees of the Township of Greenwich for the calendar year 2023 was introduced on February 21, 2023 and adopted on March 20, 2023 by the Township of Greenwich; and

WHEREAS, Resolution 73-2023 authorized the Township of Greenwich to enter into a Shared Services Agreement with the Borough of Swedesboro wherein the Township of Greenwich will provide UCC inspections for the Borough of Swedesboro, effective May 1, 2023; and

WHEREAS, the Shared Service Agreement will generate additional revenue for the Township of Greenwich but will also require more time and effort for the on the part of the employees within the Construction Department; and

WHEREAS, Mayor and Council wish to designate a salary which reflects the increase in workload for the positions within the Construction Department; and

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Greenwich, Gloucester County, New Jersey that Ordinance 3-2023 is hereby amended to reflect the following annual salary and compensation to be paid at a bi-weekly rate of pay, effective May 1, 2023:

Building Sub-Code	\$19,155.00*

Electrical Sub-Code	\$14,234.00*
Plumbing Sub-Code	\$14,234.00*
Fire Sub-Code	\$10,153.00*
