

**ORDINANCE 10-2023**

**TOWNSHIP OF GREENWICH  
COUNTY OF GLOUCESTER**

**AN ORDINANCE APPROPRIATING THE SUM OF \$366,000.00 TO BE USED FOR  
THE COMPLETION OF VARIOUS CAPITAL IMPROVEMENTS AND THE ACQUISITION  
OF VARIOUS CAPITAL EQUIPMENT WITHIN THE TOWNSHIP OF GREENWICH,  
COUNTY OF GLOUCESTER, STATE OF NEW JERSEY**

WHEREAS, the Governing Body desires to authorize the completion of various capital improvements and acquisition of various capital equipment within the Township of Greenwich: and

WHEREAS, sufficient funds are available for said purpose from the Township’s Capital Improvement Fund;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED by the Township Council of the Township of Greenwich, County of Gloucester and State of New Jersey, that:

SECTION 1: There is hereby appropriated from the following sources the sum of \$366,000.00 to be used for the following capital projects within the Township of Greenwich:

<u>Purpose/Improvement</u>	<u>Estimated Total Cost</u>	<u>Capital Improvement Fund</u>	<u>Grants</u>
A. Acquisition of Various Equipment for the Municipal Building Courtroom including, but not limited to, Sound Recorder, together with the acquisition of all materials and equipment, and completion of all work necessary therefor or related thereto	\$15,0000	\$15,000	-0-
B. Recreation Improvements including, but not limited to, installation of playground equipment, artificial Christmas tree, together with the acquisition of all materials and equipment, and completion of all work necessary therefor or related thereto	\$275.000	\$275,000	-0-
C. Acquisition of Senior Citizen’s Bus, together with the acquisition of all materials and equipment, and completion of all work necessary therefor or related thereto	\$76,000	\$76,000	-0-

SECTION 2: In connection with the amounts authorized in Section 1, the Township makes the following determinations:

- a) The purpose described in Section 1 is not a Current Expense and is an improvement, which the Township may lawfully make as a general improvement.
- b) The period of usefulness of the purpose described in Section 1 hereof is within the limitations of the Local Bond Law and according to the reasonable life thereof is five (5) years or more.
- c) No debt is authorized by this ordinance.

- d) The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the Township Clerk and available for inspection.

SECTION 3: All ordinances or parts of ordinances that are inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency.

SECTION 4: This ordinance shall take effect immediately upon proper passage, publication in accordance with law and after final adoption as provided by law.
