A local law AMENDING CHAPTER A583-28 OF THE VILLAGE CODE ENTITLED

Chapter A583 of the Village Code, entitled "Schedule of Fees, Deposits and Insurance" is hereby amended as follows:

§ A583-28 Parking Permits.

A. Employee parking. For a daytime parking permit in a Village parking field, the fee is \$90 per calendar quarter if issued prior to or during the first month of such quarter, \$70 if issued during the second month of such quarter, and \$40 if issued during the third month of such quarter.

B. Overnight parking. For an overnight parking permit in a Village parking field, the fee is \$90 per calendar quarter if issued prior to or during the first month of such quarter, \$70 if issued during the second month of such quarter, and \$40 if issued during the third month of such quarter.

C. For a temporary overnight permit in a Village parking field, the fee is \$4 per night. Such temporary parking permit is limited to a maximum of 10 nights for a total of \$40.


