#### Section I. INTENT

The Gardens at Great Neck Shopping Center ("Shopping Center"), located in the Village at the southwest corner of the intersection of Middle Neck Road and Great Neck Road, is the economic hub in the Village. Its success will also inure to the benefit of the Village and its residents. In order for the Shopping Center to remain viable, it must have adequate parking. Some of its available parking spaces are used by commuters who travel elsewhere or by persons who are not actually visiting stores in the Shopping Center. NYS Vehicle and Traffic Law Section 1640-A authorizes the Village to regulate by local law, when requested to do so, parking and traffic in the parking lot of a shopping center and to enforce such regulations. The owner of the Shopping Center has requested the Village to do so, and the Village has entered into an agreement to do so, subject to certain conditions. The Village Board of Trustees now enacts the following amendments to Chapter 206 of the Village Code to authorize the enforcement of overtime parking restrictions in the Shopping Center parking lot and the collection of fines for violation thereof since such. Such amendments will increase parking availability in the Shopping Center and thereby benefit the health, welfare and safety of the Village and its residents.

#### Section II. Amendments

A. Chapter 206-58.1 of the Village Code (currently marked "Reserved") is hereby amended to state as follows:

### "206-58.1. Gardens of Great Neck Shopping Center parking lot.

- A. Effective October 1, 2024, or on such later date as the Village Board of Trustees ("Board") may hereinafter designate, parking of vehicles in the parking lot ("Parking Lot") of the Gardens of Great Neck Shopping Center ("Shopping Center") located at the southwest corner of the intersection of Middle Neck Road and Great Neck Road, shall be limited to three hours from 9:00 am to 5:00 pm on Monday through Saturday (inclusive) but excluding Village holidays. Such time limits may be subsequently modified by resolution or local of the Village Board of Trustees ("Board")
- B. The time-limit parking restrictions in the Parking Lot shall be enforced by the chalking of vehicles and issuance of summonses by the Village's code enforcement officers and by the imposition and collection of fines by the Village Court.
- C. The fine for a violation of the time-limit restriction in the Parking Lot shall be \$100, as set forth in Village Code Section 206-66 (A), unless hereinafter amended by resolution or local law of the Board.
- D. The time-limit parking restrictions set forth above shall not apply to any employee or owner of a tenant in the Shopping Center who parks in the Parking Lot and whose vehicle displays a sticker from the owner of the Shopping Center approved by the Village for issuance to said persons.
- E. These time-limit parking restrictions shall not be enforced by the Village if the owner of the Shopping Center fails to:
  - (1) install signage in the Parking Lot in accordance with its agreement with the Village and which the Village determines to be necessary and appropriate; or
  - (2) maintain insurance coverage insuring the Village and its employees in the manner and amount which the Village determines to be necessary and appropriate; or
  - (3) breaches its agreement with the Village regarding such enforcement.

- F. This section shall remain in effect only during such periods of time as there exists a valid agreement between it and the owner of the Shopping Center authorizing the Village to enforce parking regulations in the Parking Lot pursuant to NYS VTL 1640-A."
- B. Chapter 206-66 (A) of the Village Code is hereby amended by adding thereto the following violation:

## Section III. Severability

The invalidity of any sentence, part or provision of this local law shall not affect the validity of any other part of the Local Law which can be given effect without such invalid part of parts.

#### Section IV. Effective Date

This local law shall become effective immediately as provided in the Municipal Home Rule Law upon being filed in the Office of the Secretary of State.
