Pursuant to the Authority conferred in Section 7-700 of the Village Law of the State of New York, the Board of Trustees of the Village of Green Island hereby adopts and enacts Local Law No. 1 of 2023 to add the following street in Section 43 of Chapter 157 - Schedule XI: Parking Prohibited at All Times as follows:

Name of Street	Side	Location
Cohoes Avenue	West	Northwest corner of the intersection of Cohoes Avenue and Arch Street northerly along the west side of Cohoes Avenue for a distance of 125 feet.
Cohoes Avenue	East	Northeast corner of the intersection of Cohoes Avenue and Arch Street northerly along the east side of Cohoes Avenue for a distance of 92 feet.

This local law shall take effect upon filing in the office of the Secretary of State of the State of New York.
