ORDINANCE #106-2023

AN ORDINANCE TO DETERMINE AND FIX THE SALARIES AND WAGES OF CERTAIN OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF GREENWICH, IN THE COUNTY OF WARREN AND STATE OF NEW JERSEY

BE IT ORDAINED by the Township of Greenwich, in the County of Warren and State of New Jersey, as follows:

SECTION 1. The salaries or wages to be paid certain officers or employees of the Township of Greenwich are hereby determined and fixed at the following amounts or rates, or ranges of amounts or rates, for the calendar year 2023 and until the same are amended by subsequent ordinance of this Township:

SECTION 2. The annual salaries for the Police Officers set forth above shall be the basic annual salary ranges for the year and paid in accordance with the current Police contract.

SECTION 3. This Ordinance shall repeal all other ordinances or portions of ordinances inconsistent herewith.

Severability. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.”

BE IT FURTHER ORDAINED by said Township Committee that this Ordinance shall take effect immediately after final adoption and publication as provided by law. Upon this ordinance taking effect, the salaries and wages set forth herein shall be retroactive to January 1, 2023.
