

**AN ORDINANCE OF THE CITY OF GREENWOOD BOARD OF ALDERMEN
APPOINTING AARON THOMAS AS THE
ASSISTANT CITY ADMINISTRATOR AND CITY CLERK
FOR THE CITY OF GREENWOOD, MISSOURI**

WHEREAS, the Board of Aldermen directed that a search be conducted to fill the position of Assistant City Administrator and City Clerk;

WHEREAS, City staff conducted a position search, received numerous applications, conducted five first round interviews and two finalist interviews for the position of Assistant City Administrator and City Clerk;

WHEREAS, the Board of Aldermen desire to elect Aaron Thomas as the Assistant City Administrator and City Clerk and fulfill the duties of the City Clerk as set forth in Code § 110.070, and RSMo. § 79.320.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF GREENWOOD, MISSOURI AS FOLLOWS:


Section 1. That the Board of Aldermen hereby elects Aaron Thomas as the Assistant City Administrator and City Clerk and elects him to fulfill the duties of the City Clerk set forth in Code § 110.070 and RSMo. § 79.320.

Section 2. This Ordinance shall be in full force and effect from and after the date of its passage and approval.

Section 3. That the Mayor, and other appropriate City officials are hereby authorized to take any and all actions as may be deemed necessary or convenient to carry out and comply with the intent of this Ordinance and to execute and deliver for and on behalf of the city all certificates, instruments, agreements and other documents, as may be necessary or convenient to perform all matters herein authorized.
