

**ORDINANCE NO. 764**

**ORDINANCE AMENDING WATER SERVICE CHARGE  
AND SANITARY SEWER SERVICE CHARGE ORDINANCE**

WHEREAS, the Village of Granville, Illinois, A Municipal Corporation, considers it in the best interest of the public health, safety and morals to amend the previous Water Service Charge Ordinance No. 480 as it is amended by Ordinances No. 488, 520, 530, 567, 660, 684 and 742.

NOW, THEREFORE, be it ordained by the President and Board of Trustees of the Village of Granville, Putnam County, Illinois, a municipal corporation, as follows:

**SECTION I:**

Ordinance Nos. 480, 488, 520, 530, 567, 660, 684 and 742 shall be amended for ARTICLE I, SECTION 10 thereof with the amendatory Section 10 be as follows:

**SECTION 10: RATES:**

- A. A minimum charge of \$55.00 per month shall be applied to all users within the village limits whose water consumption does not exceed 2,000 gallons per month. This minimum charge shall consist of \$20.00 for water service, \$14.00 for sewer service, \$10.00 for Capital Improvement, and \$11.00 for Sewer Debt Service. Usage in excess of 2,000 gallons per month will be charged at a rate of \$17 per 1,000

gallons. This is \$8.50 each per 1,000 gallons for water and sewer. The rates will apply for all bills due after May 1, 2024.

- B. A minimum charge of \$58.00 per month shall be applied to all users within the village limits whose water consumption does not exceed 2,000 gallons per month. This minimum charge shall consist of \$21.00 for water service, \$15.00 for sewer service, \$11.00 for Capital Improvement, and \$11.00 for Sewer Debt Service. Usage in excess of 2,000 gallons per month will be charged at a rate of \$18 per 1,000 gallons. This is \$9.00 each per 1,000 gallons for water and sewer. The rates will apply for all bills due after May 1, 2025.
- C. A minimum charge of \$61.00 per month shall be applied to all users within the village limits whose water consumption does not exceed 2,000 gallons per month. This minimum charge shall consist of \$22.00 for water service, \$16.00 for sewer service, \$12.00 for Capital Improvement, and \$11.00 for Sewer Debt Service. Usage in excess of 2,000 gallons per month will be charged at a rate of \$19 per 1,000 gallons. This is \$9.50 each per 1,000 gallons for water and sewer. The rates will apply for all bills due after May 1, 2026.
- D. A minimum charge of \$65.00 per month shall be applied to all users outside the village limits whose water consumption does not exceed 2,000 gallons per month when said users have both water and sewer together. This minimum charge shall consist of \$23.00 for water service, \$21.00 for sewer service, \$10.00 for Capital Improvement, and \$11.00 for Sewer Debt Service. Usage in excess of 2,000 gallons per month will be charged at a rate of \$9.50 per 1,000 gallons each for both water and sewer service. The rates will

apply for all bills due after May 1, 2024. In the event the user has only one of the services, they will be charged according to this price structure.

E. A minimum charge of \$68.00 per month shall be applied to all users outside the village limits whose water consumption does not exceed 2,000 gallons per month when said users have both water and sewer together. This minimum charge shall consist of \$24.00 for water service, \$22.00 for sewer service, \$11.00 for Capital Improvement, and \$11.00 for Sewer Debt Service. Usage in excess of 2,000 gallons per month will be charged at a rate of \$10.00 per 1,000 gallons each for both water and sewer service. The rates will apply for all bills due after May 1, 2025. In the event the user has only one of the services, they will be charged according to this price structure.

F. A minimum charge of \$71.00 per month shall be applied to all users outside the village limits whose water consumption does not exceed 2,000 gallons per month when said users have both water and sewer together. This minimum charge shall consist of \$25.00 for water service, \$23.00 for sewer service, \$12.00 for Capital Improvement, and \$11.00 for Sewer Debt Service. Usage in excess of 2,000 gallons per month will be charged at a rate of \$10.50 per 1,000 gallons each for both water and sewer service. The rates will apply for all bills due after May 1, 2026. In the event the user has only one of the services, they will be charged according to this price structure.

## SECTION II:

### Validity


If any Section, paragraph, clause, or provision of this Ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such Section, paragraph, clause, or provisions shall not affect any of the remaining provisions of this Ordinance.

SECTION III:

This Ordinance shall be in full force and effect from and after its passage and approval and publication in the manner provided by law.


