**ORDINANCE #04-20**

**AMENDING CHAPTER 2 ENTITLED “ADMINISTRATION”  
OF THE REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG  
COUNTY OF HUDSON, STATE OF NEW JERSEY**

**WHEREAS**, pursuant to N.J.S.A. 40:48-2, a municipality may make, amend, repeal and enforce ordinances not contrary to the laws of this State or of the United States, as it may deem necessary and proper for order and protection of persons and property, and for the preservation of the public health, safety and welfare of the municipality and its inhabitants; and

**WHEREAS**, the Town of Guttenberg (the “Town”) is a municipality as defined by Title 40 of the New Jersey Statutes; and

**WHEREAS**, the Town wishes to amend the meeting start time.

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey, that Chapter 2 entitled “Administration,” Section 2-2 entitled “Time of Meeting Established,” is hereby amended as follows: (**additions are underlined; deletions are in [brackets]**):

**Article II Meetings of the Board of Council**

**2-2 TIME OF MEETING ESTABLISHED.**

In accordance with *N.J.S.A.* 40:45 A-1, the annual reorganization meeting of the Mayor and Board of Council of the Town of Guttenberg shall be held at **7:00 p.m.** [8:00 p.m.] on the first Wednesday of January except that should January 1 fall on Wednesday, then the reorganization meeting shall be held at **7:00 p.m.** [8:00 p.m.] on January 2 that year.

**SECTION TWO**

**Severability.** The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

### **SECTION THREE**

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

### **SECTION FOUR**

The Ordinance shall become effective immediately upon final adoption and publication thereof according to law.

### **Summary of Ordinance**

This purpose of this ordinance is to amend Chapter 2, Section 2-2 entitled “Time of Meeting Established” to update time of meeting to 7:00 p.m.
