ORDINANCE #10-20

**AMENDING CHAPTER VII ENTITLED "TRAFFIC"
SECTION 7-7 ENTITLED "LOADING ZONE"
OF THE REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG**

WHEREAS, Chapter 7 of the Code of the Town of Guttenberg ("Code"), entitled "Traffic" and Section 7-7, entitled "Loading Zone," sets forth the rules and regulations for the creation or continuance of a restricted parking space for use as an unloading zone; and

WHEREAS, the Town of Guttenberg seeks to modify the current loading zone location to Boulevard East.

NOW THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey, that Chapter VII, entitled "Traffic" Section 7-7 entitled "Loading Zone" is hereby amended as follows:

SECTION ONE

Chapter VII, entitled "Traffic" Section 7-7 entitled "Loading Zone" shall be amended as follows: (**additions are underlined; deletions are in [brackets]**):

Business	Address	Time
1. Benny's Liquor & Deli	7000 Park Avenue	6:00 AM to 6:00 P.M. Mon to Sat

The loading zone shall be located on 70th Street, alongside the business location and shall commence from the Stop on 70th Street running easterly approximately 41 feet to the rear of the building.

SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION THREE

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the

legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION FOUR

The Ordinance shall become effective immediately upon final adoption and publication thereof according to law.

Summary of Ordinance

This purpose of this Ordinance is to expand the current loading zone for Benny's Liquor & Deli.
