**ORDINANCE #13-20**

**AMENDING CHAPTER VII ENTITLED “TRAFFIC”  
OF THE REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG**

**WHEREAS**, Chapter VII of the Code (“Code”) of the Town of Guttenberg (“Town”) entitled, “Traffic,” subsection 7-5 entitled “One-Way Street” sets forth all the one-way streets in the Town of Guttenberg; and

**WHEREAS**, the Town of Guttenberg wishes to create two additional one-way street designations on Jackson Street and Adams Street.

**NOW THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey, to amend Chapter VII, entitled “Traffic” subsection 7-5 entitled “One –Way Street” as follows:

**SECTION ONE**

**Chapter 7-5 ONE-WAY STREET**

The following described streets or parts of streets are hereby designated as one-way streets in the direction indicated. [Additions are in **BOLD**]

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Adams Street (Ord. No. 24-2016)	South	From 70th Street to the 68th Street
Bellevue Avenue (Ord. No. 24-2016)	South	From the Town limits to 68th Street
Hudson Avenue (Ord. No. 24-2016)	North	Entire length
Jackson Street (Ord. No. 24-2016)	North	From the 68th Street to 70th Street
Madison Street (Ord. No. 24-2016)	North	From 68th Street to the Town limits
Palisade Avenue (Ord. No. 24-2016)	South	Entire length
Polk Street (Ord. No. 24-2016)	South	From the Town limits to 68th Street
68th Street (Ord. No. 24-2016)	West	From Boulevard East to Bergenline Avenue

69th Street (Ord. No. 24-2016)	East	From Bergenline Avenue to Boulevard East
70th Street (Ord. No. 24-2016)	West	From Boulevard East to Bergenline Avenue
71st Street (Ord. No. 24-2016)	East	From Palisade Avenue to Boulevard East
Jackson Street	North	From border of West New York to 68 <sup>th</sup> Street
Polk Street	South	From 68 <sup>th</sup> Street to border of West New York
<b>Adams Street</b>	<b>North</b>	<b>From 70th Street to 73<sup>rd</sup> Street</b>
<b>Jackson Street</b>	<b>South</b>	<b>From 73<sup>rd</sup> Street to 70<sup>th</sup> Street</b>

## SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

## SECTION THREE

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

## SECTION FOUR

The Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
