ORDINANCE #16-20

**AN ORDINANCE ESTABLISHING CHAPTER IX OF THE
REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG FOR
RECREATION PROGRAMS**

WHEREAS, the Town Administrator and Director of Recreation have recommended that the Town adopt an ordinance establishing the fees that may be charged by the Town regarding participation in Town recreation programs; and

WHEREAS, the Mayor and Council have considered this recommendation and agree with it.

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey that the Revised General Ordinances of the Town of Guttenberg is hereby amended as follows:

SECTION ONE

Initial Fees. The following initial fee schedule shall apply to the following Town recreation programs:

Basketball

5-8 Yr. Old Clinic	\$20.00
8-11 Yr. Old League	\$20.00
11-14 Yr. Old League	\$20.00
14-17 Yr. Old League	\$20.00
Adult league 18+	\$20.00
Youth Travel League/Tournament	\$600-\$800 (depending on grade level and number of games)

Open Gym	\$20.00
Baton Twirling	\$20.00
Dance	\$20.00
Cheerleading	\$20.00
Arts & Crafts	\$20.00
Soccer	\$20.00
Summer Camp	\$35.00
Summer Bowling	\$10.00
Pickleball	\$0.00 - \$20.00

Ping Pong	\$0.00 - \$20.00
Zumba (Adult)	\$0.00 - \$20.00
Yoga	\$0.00 - \$20.00
Volleyball	\$0.00 - \$20.00

Such fees shall be posted where deemed appropriate to do so, and shall be made available to a requestor upon request.

SECTION TWO

Subsequent and Additional Fees and Amendments to Established Fees. Where the adopted schedule provides for a range of fees the Mayor and Council, by resolution, and the Director of Recreation, by way of correspondence to the Mayor and Council, shall be and they are hereby empowered to establish the appropriate fee within such range, and when once thus established, such fees shall be posted where deemed appropriate to do so, and shall be made available to a requestor upon request.

SECTION THREE

Retroactive Effect & Ratification of Previous Fees. This Ordinance shall have retroactive effect. Any fees established and/or charged in excess of the fees set forth in this Ordinance, or as to recreation programs not listed herein, prior to the effective date of this Ordinance, are hereby ratified in their entirety.

SECTION FOUR

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remain in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION FIVE

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION SIX

Codification. The Town Clerk shall have this Ordinance incorporated in the official copies of the Revised General Ordinances. The Town Clerk and the Town Attorney shall be and are hereby authorized and directed to change any heading, chapter numbers, article numbers and section numbers in the event that the codification of this Ordinance reveals that there is a conflict between

those headings and numbers and existing provisions of the Revised General Ordinances of the Town of Guttenberg, or as they may otherwise deem appropriate.

SECTION SEVEN

Subject to Section Six, it is intended that this Ordinance be codified as Chapter IX of the Revised General Ordinances of the Town.

SECTION EIGHT

This Ordinance shall take effect upon passage and publication as required by law.
