ORDINANCE #18-20

**AN ORDINANCE OF THE TOWN OF GUTTENBERG AMENDING THE TOWN
CODE, CHAPTER 7, TRAFFIC, SECTION 7-9, DESIGNATING BUS STOPS IN THE
TOWN OF GUTTENBERG**

WHEREAS, Chapter 7, of the Code of the Town of Guttenberg (“Code”) entitled “Traffic,” Section 7-9 entitled “Bus Stops” designates bus stops throughout the Town of Guttenberg; and

WHEREAS, the Town has determined for public health and safety issues that the bus stop located at the northwest corner of 7101 Park Avenue should be reduced from 41 feet in length to 19 feet in length; and

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey, that Chapter 7-9 entitled, “Bus Stops” be amended to reduce the length of the parking stop at Northwest corner at 7101 Park Avenue, as follows:

SECTION ONE

7-9 Bus Stops

Park Avenue:

Northwest corner at 6801 Park Avenue - extending 30 feet

Northwest corner at 6901 Park Avenue - extending 31 feet

Northwest corner at 7001 Park Avenue - extending 28 feet

Northeast corner at 7100 Park Avenue - extending 22 feet

Northwest corner at 7101 Park Avenue - extending 19 feet

Southeast corner at 6812 Park Avenue - extending 29 feet

SECTION TWO

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION THREE

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION FOUR

This Ordinance shall take effect upon passage and publication as required by law.

Summary of Ordinance

The purpose of this ordinance is to amend Chapter 7-9 entitled “Bus Stops” to reduce the length the Bus Stop located at the Northwest corner of 7101 Park Avenue from 41 feet to 19 feet in length.
