**ORDINANCE #20-20**

**AMENDING CHAPTER VII ENTITLED "TRAFFIC"  
SECTION 7-7 ENTITLED "LOADING ZONE"  
OF THE REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG**

**WHEREAS**, Chapter 7 of the Code of the Town of Guttenberg ("Code"), entitled "Traffic" and Section 7-7, entitled "Loading Zone," sets forth the rules and regulations for the creation or continuance of a restricted parking space for use as an unloading zone; and

**WHEREAS**, the Town of Guttenberg seeks to remove the designated loading zones for Deerbrook Fabrics (Stick O Matic) located at 425-427 69th Street, Guttenberg, NJ and High Accessories located at 72 68th Street, Guttenberg, NJ.

**NOW THEREFORE, BE IT ORDAINED**, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey, that Chapter VII, entitled "Traffic" Section 7-7 entitled "Loading Zone" is hereby amended as follows:

**SECTION ONE**

Chapter VII, entitled "Traffic" Section 7-7 entitled "Loading Zone" shall be amended to **DELETE** the following:

**SECTION TWO**

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

### **SECTION THREE**

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

### **SECTION FOUR**

The Ordinance shall become effective immediately upon final adoption and publication thereof according to law.

### **Summary of Ordinance**

The purpose of this Ordinance is to remove the loading zones for Deerbrook Fabrics (Stick O Matic) located at 425-427 69<sup>th</sup> Street, Guttenberg, NJ and High Accessories located at 72 68<sup>th</sup> Street, Guttenberg, NJ.
