ORDINANCE #13-23

**AN ORDINANCE SETTING CERTAIN FINES AMENDING SECTION 8-17 OF THE
REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG**

WHEREAS, the Municipal Court administrator has requested that certain violations be made non-mandatory court appearances and the Town administration agrees;

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey that the Revised General Ordinances of the Town of Guttenberg is hereby amended as follows:

SECTION I.

§ 8-17 “VIOLATIONS” of the Revised General Ordinances of the Town of Guttenberg is hereby amended to read as follows:

- a. Any person, whether they possess a parking permit or not, parked in violation of the provisions of this section, or in violation of any of the rules promulgated by the Town Administrator pursuant to this section, shall be liable for a fine of \$100.00, and/or towed as provided by this section.
- b. Any vehicle parked in any Housing Authority Parking Area in violation of any rules or regulations of the Guttenberg Housing Authority may be subject to a fine of \$100.00, and/or towed as provided by this section.

SECTION II.

Severability. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remain in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION III.

Repealer. All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency.

SECTION IV.

Codification. The Town Clerk shall have this Ordinance incorporated in the official copies of the Revised General Ordinances. The Town Clerk and the Town Attorney be and are hereby authorized and directed to correct any typographical error and to change any heading, chapter numbers, article numbers and section numbers in the event that the codification of this Ordinance reveals that there is a conflict between those headings and numbers and existing provisions of the Revised General Ordinances of the Town of Guttenberg, or as they may otherwise deem appropriate, even if headings, chapter numbers, article numbers and section numbers are otherwise provided for in this Ordinance.

SECTION V.

This Ordinance shall take effect upon passage and publication as required by law.

Summary of Ordinance

This Ordinance amends certain penalties so as to avoid mandatory court appearances for certain violations.
