ORDINANCE #15-23

AMENDING CHAPTER VII ENTITLED "TRAFFIC" SECTION 7-7 ENTITLED "LOADING ZONE" OF THE REVISED GENERAL ORDINANCES OF THE TOWN OF GUTTENBERG - MASTER AUTO SERVICE CENTER

WHEREAS, Chapter 7 of the Code of the Town of Guttenberg ("Code"), entitled "Traffic" and Section 7-7, entitled "Loading Zone," sets forth the rules and regulations for the creation or continuance of a restricted parking space for use as an unloading zone; and

WHEREAS, Master Auto Service Center has applied for a loading zone in front of 431 70th Street, Guttenberg, New Jersey; and

WHEREAS, the Police Department has reviewed said applications and have not raised objections thereto and the grant of such loading zone will not adversely impact parking availability.

NOW THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Guttenberg, County of Hudson, State of New Jersey, that Chapter VII, entitled "Traffic" Section 7-7 entitled "Loading Zone" is hereby amended to renew the following parking spaces restricted for use as a loading zone, as follows:

SECTION ONE

Chapter VII, entitled "Traffic" Section 7-7 entitled "Loading Zone" shall also include the following:

SECTION THREE

<u>Severability</u>. The provisions of this Ordinance are declared to be severable and if any section, subsection, sentence, clause or phrase thereof for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sections, subsections, sentences, clauses and phrases of this Ordinance, but shall remaining in effect; it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

SECTION FOUR

<u>Repealer.</u> All Ordinances or parts thereof in conflict or inconsistent with this Ordinance are hereby repealed, but only however, to the extent of such conflict or inconsistency, it being the legislative intent that all Ordinances or part of ordinances now existing or in effect unless the same being conflict or inconsistent with any provision of this Ordinance shall remain in effect.

SECTION FIVE

The Ordinance shall become effective immediately upon final adoption and publication thereof according to law.

Summary of Ordinance

The purpose of this Ordinance is to restrict for use as loading zones the aforementioned parking spaces.
