Section 1: This local law amends Local Law #10 of the year 1986 of the Code of the Town of Hamburg, Chapter 280 entitled "Zoning: to provide for a change in the boundary of the Zoning Map whereby the zoning is changed from R-2 to C-1 for the properties identified by SBL Numbers: 160.08-2-6.1, 160.08-2-10.1, 160.08-2-17, 160.08-2-14, 160.08-2-13 and 160.08-2-5 located at 3520 Abbott Road, 5120 Stewart Road and vacant parcels on Milestrip Road.
