A local law to amend Local law #10 of the year 1986 of the Code of the Town of Hamburg, Chapter

280 entitled "Zoning" to provide for a change in the boundary of the Zoning Map whereby
the Zoning is changed from M-2 (Light Industrial) to C-2 (General Commercial) and N-C
Neighborhood Commercial General Residence District) as outlined below

Section 1: This local law amends Chapter 280 of the Hamburg Town Code entitled "Zoning" by amending the boundaries of the zoning map as follows: rezone parcels on the east side of the railroad near Lakeview Road with the following SBL numbers from M-2 (Light Industrial) to C-2 (General Commercial): 193.00-4-7; 193.00-4-6; 193.00-4-5; 193.00-4-4; and SBL Numbers 193.00-4-35. SBL Numbers 193.00-4-3.11 and 193.00-4-2 are rezoned from M-2 (Light Industrial) to N-C (Neighborhood Commercial General Residence District.)
