RESOLUTION AND FINAL ORDER INTRODUCTORY LOCAL LAW #8 - 2023
A local law proposed to amend Chapter 454 Article VI (Trailers Situated Outside Parks or Camps §454-22) the Code of the Town of Hamlin
WHEREAS, the Town Board of the Town of Hamlin did heretofore publish Legal Notice to consider the enactment of Introductory Local Law #8 – 2023 amending Chapter 454 Article VI §454-22 of the Code of the Town of Hamlin; and
WHEREAS, pursuant to Legal Notice duly published, the Town Board of the Town of Hamlin did hold and conduct a Public Hearing to consider such Introductory Local Law, which public hearing was held and conducted at the Hamlin Town Hall, 1658 Lake Road, Hamlin, New York on the 10th day of July, 2023, at 7:00 p.m. and at which hearing all interested persons were heard concerning the subject matter thereof; and
WHEREAS, after due consideration, the Town Board is desirous of enacting such Local Law;
NOW, THEREFORE, be it resolved by the Town Board of the Town of Hamlin, Monroe County, New York, as follows:

SECTION 1. That the enactment of this Local Law is a Type 2 Action in that it is a routine or continuing governmental administration and management activity, and as such the enactment of this local law may proceed without further regard to the State Environmental Quality Review Act.

SECTION 2. That the Town Board of the Town of Hamlin by adoption of this Resolution does hereby enact Introductory Local Law #8-2023 amending Chapter 454 Article VI §454-22 of the Code of the Town of Hamlin to read and provide as follows:

§ 454-22 Storage of trailers.
[Amended 8-14-2017 by L.L. No. 5-2017]

- A. The storage, garaging or parking of any unlicensed trailer, including but not limited to any automobile trailer, house trailer, mobile home or camping trailer or boat trailer, either within or without a structure or building is permitted, provided that such trailer is unoccupied and is not used for sleeping or living purposes, and provided that only one unlicensed trailer is parked or stored on any one premises outside an existing building, and provided that the trailer shall comply with the setback requirements of Chapter 520, Zoning, of the Code of the Town of Hamlin, as it may be amended from time to time.
- B. A licensed camping unit, house trailer, travel trailer or trailer may be stored on any parcel of land that is owned by the same individual that owns said licensed camping unit, house trailer, travel trailer or trailer and being stored on said real property. Subject to Use Restrictions set out in §454-20 of this code.

SECTION 3. That the Town Clerk shall give due notice of the enactment of this local Law by filing the same with the Secretary of State, as required.
