AN ORDINANCE

AN ORDINANCE AMENDING ORDINANCE NO. 2113 ENTITLED, "AN ORDINANCE OF THE BOROUGH OF HANOVER, YORK COUNTY, PENNSYLVANIA, ESTABLISHING A PROGRAM FOR COLLECTION, STORAGE, TRANSPORTATION, PROCESSING AND DISPOSAL OF MUNICIPAL WASTE AND RECYCLING, INCLUDING MANDATORY SOURCE SEPARATION AND SEPARATE COLLECTION OF DESIGNATED RECYCLABLE MATERIALS, PROHIBITING THE DISPOSAL OF DESIGNATED RECYCLABLES AND LEAF WASTE; EMPOWERING THE BOROUGH OF HANOVER TO ADOPT AND PROMULGATE REASONABLE REGULATIONS THEREOF; FIXING PENALTIES FOR VIOLATION OF THIS ORDINANCE," AS SET FORTH IN CHAPTER 308 OF THE CODE OF ORDINANCES OF THE BOROUGH OF HANOVER."

BE IT ENACTED AND ORDAINED by the Council of the Borough of Hanover, York County, Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1: That Ordinance No. 2113 is hereby amended.

SECTION 2: That Chapter 308 Solid Waste, Section 11 - Paragraph A and Paragraph B of the *Code of Ordinances of The Borough of Hanover* entitled, "Separation of designated recyclables," shall be amended to read as follows:

- A. Designated recyclables shall be kept separate from municipal waste for the purpose of mandatory curbside recycling to the extent required by the following provisions:
- (1) Owners and occupants of all residential properties shall keep separate the following designated recyclables: aluminum cans, corrugated paper (cardboard), high-grade office paper and bi-metal cans. Leaf waste shall be kept separate unless they have otherwise provided for composting.
 - (2) Owners and occupants of all commercial, municipal and institutional establishments and properties and sponsors or organizers of community activities shall keep separate the following designated recyclables: aluminum cans corrugated paper (cardboard), high-grade office paper and bimetal cans. Leaf waste shall also be kept separate unless they have otherwise provided for composting.
 - (3) Additionally, the Borough may by resolution enumerate additional recyclables that will be required to be separated from municipal waste and collected in accordance with this chapter.
- B. The following are the placement procedures for the curbside collection of designated recyclables. Aluminum and bi-metal cans shall be emptied and cleaned. Corrugated cardboard shall be tied together or placed in closeable refuse bags so it cannot become airborne not to exceed fifty (50) pounds. High-grade office paper shall be placed in closable refuse bags so it cannot become airborne not to exceed fifty (50) pounds. Recyclables shall be placed at the curb or alleyway where refuse/garbage is collected. Recyclables shall not be otherwise mixed with municipal waste for collection, removal or disposal. Leaf waste shall be set out for collection in a manner to be designated by the Borough. Storm damaged tree branches and shrubbery shall be collected by The Borough when placed at the curb or alleyway for collection in a manner prescribed by the Borough Manager.




