MONTGOMERY COUNTY, PENNSYLVANIA**

ORDINANCE NO. 1046

AN ORDINANCE OF THE BOROUGH OF HATBORO, MONTGOMERY COUNTY, PENNSYLVANIA AMENDING THE CODE OF ORDINANCES OF HATBORO BOROUGH, 1005, PART 4: SECTION 15-405 TO CREATE TWO HOUR AND PERMIT PARKING IN ENUMERATED LOCATIONS IN THE BOROUGH, REPEALING ALL INCONSISTENT ORDINANCES OR PARTS THEREOF; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Borough of Hatboro desires to protect the safety, health and welfare of the residents of Hatboro by preserving the livability and desirability of its neighborhoods;

WHEREAS, the members of Council recognize that certain streets in the Borough do not have sufficient on or off-street parking to accommodate the convenient parking of the residents' motor vehicles in the vicinity of their homes;

WHEREAS, Hatboro Borough Council has determined that some streets in the Borough are burdened by the parking of motor vehicles by non-residents and commuters, which compete with the residents and businesses in the neighborhoods for the available on street parking spaces;

WHEREAS, Council wishes to limit parking without a permit in these areas to two hours on weekdays;

WHEREAS, the Borough will issue two parking permits per household for residents living on the street locations enumerated in this Ordinance;

WHEREAS, vehicles without a permit needing additional time to park in the vicinity of the proposed restriction can park in readily available commuter parking lots located nearby;

NOW, THEREFORE, be it, and it is hereby **ORDAINED** by the Hatboro Borough Council, and it is hereby **ENACTED** and **ORDAINED** by authority of same as follows:

I. Section 15-405 of the Code of Ordinances of Hatboro Borough is amended as follows:

§15-405 Parking Time Limited in Certain Locations, Certain Days, and Hours.

1. **Restricted Parking:** No person shall park a vehicle, or allow it to remain parked, for longer than the time indicated, in any of the following locations, at any time on the days and between the hours indicated:

2. **Two Hour Parking:** No vehicle shall be permitted to park for longer than two hours without a Borough issued permit on weekdays at the following locations and times:

E. Montgomery Avenue	Both	13-121	6:00 a.m.-6:00 p.m.
E. Moreland Avenue	Both	68-153	6:00 a.m.-6:00 p.m.
Central Avenue	Both	211-246	6:00 a.m.-6:00 p.m.

3. Parking Permits: Each household with an address enumerated in §15-405.2 shall be issued two parking permits by the Borough. The parking permit must be placed in the back windshield of vehicles that are parked on streets enumerated §15-405.2.

4. Weekends and Holidays: The provisions in §15-405.2 shall not apply to weekends and legal holidays as defined in §15-101.

II. REPEALER

Any and all terms, conditions and provisions of any Ordinance or Resolution of Hatboro Borough in conflict with the terms, conditions and provisions of this Ordinance, are hereby repealed to the extent of such conflict.

III. SEVERABILITY

Is it hereby declared to be the legislative intent, that if a court of competent jurisdiction declares any provision of this Chapter to be invalid or ineffective in whole or in part, the effect of such decision shall be limited to those provisions which are expressly stated in the decision to be invalid or ineffective, and all other provisions of this Chapter shall continue to be separately and fully effective.


IV. EFFECTIVE DATE


This ordinance shall be effective immediately upon its legal enactment by the Borough Council of the Borough of Hatboro.
