ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, PART II, GENERAL LEGISLATION, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-9, PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS (Parent Avenue) AND ARTICLE III, TRAFFIC REGULATIONS, § 485-28, RIGHT TURN ONLY (Parent Avenue onto South Broad Street)

Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Part II, General Legislation, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-9, Parking prohibited at all times on certain streets, and Article III, Traffic Regulations, § 485-28, Right turn only*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-9. Parking prohibited at all times on certain streets.

No person shall park a vehicle at any time upon any streets or parts thereof described.


§ 485-28. Right turn only.


No person shall make a turn at the below listed location other than a right turning movement.
