

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HAMILTON, IN THE COUNTY OF MERCER, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The aggregate amount of \$7,605,000.00 is hereby appropriated for the following purposes through \$6,560,000.00 funded from the Capital Surplus account in the General Capital Fund and \$1,045,000.00 funded from two grants expected from the State of New Jersey:

The \$1,045,000.00 expected to be received in two State of New Jersey, Department of Transportation Grants are hereby appropriated to any or all of the foregoing purposes.

Section 2. The current balance in the capital surplus account of the General Capital fund is sufficient to fund the appropriations listed in Section 1.

Section 3. The ordinance could be funded by the issuance of bonds if it were not being permanently funded from capital surplus of the General Capital fund.

Section 4. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the

resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program is approved by the Director of the Division of Local Government Services is on file with the Township Clerk and is available there for public inspection.

Section 5. The following additional matters are hereby determined, declared, recited and stated:

(a) The several improvements or purposes described in Section 1 of this bond ordinance are not current expenses. They are improvements or purposes the Township may lawfully undertake as general improvements, and no part of the costs thereof have been or shall be specially assessed on property specially benefitted thereby.

(b) The average period of usefulness of the several improvements or purposes, computed on the basis of the respective amounts or obligations authorized for each improvement or purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 9.848586 years.

Section 6. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.
