



**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, PART II, GENERAL LEGISLATION, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE III, TRAFFIC REGULATIONS, § 485-27, TURN PROHIBITIONS**

*Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey, Part II, General Legislation, Chapter 485, Vehicles and Traffic, Article III, Traffic Regulations, § 485-27, Turn prohibitions*, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article III - Traffic Regulations**

**§ 485-27. Turn prohibitions.**

No person shall turn at the below described locations as indicated.




