

ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing space for 25 Moffatt Avenue; 239 Parkinson Avenue; and 1010 William Street)

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II; Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

.....

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

<i>Street</i>	<i>Location</i>
<u>25 Moffatt Avenue Hamilton, New Jersey 08629</u>	<u>Beginning at a point 27 feet north of Sykes Avenue and extending to a point 49 feet north of Sykes Avenue along the west bound curb line of Moffatt Avenue.</u>

<u>239 Parkinson Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 72 feet west of Lida Street and extending to a point 94 feet west of Lida Street along the south bound curb line of Parkinson Avenue.</u>
<u>1010 William Street</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 94 feet east of Joseph Street and extending to a point 116 feet east of Joseph Street along the north bound curb line of William Street.</u>

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.

This Ordinance shall become effective immediately upon final adoption and publication thereof according to law.
