Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of the Township of Hamilton, New Jersey*, Chapter 485, *Vehicles and Traffic*, Article II, *Parking*, § 485-13, *Parking prohibited during certain hours on certain streets except for Sundays and public holidays*, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

.....

§ 485-13 Parking prohibited during certain hours on certain streets except for Sundays and public holidays.

No person shall park a vehicle between the hours specified any day (except Sundays and public holidays) upon any of the streets or parts of streets described.
