## AN ORDINANCE AUTHORIZING THE CHANGE IN NAME OF THAT CERTAIN ROADWAY IN THE TOWNSHIP OF HAMILTON WHICH IS PRESENTLY KNOWN AS OLIVIA AVENUE WHICH SHALL HEREAFTER BE NAMED AS BRIAN SUTTON SR. WAY

Whereas the Township of Hamilton Fire Division, FMBA Local 84 and FMBA Local 284 ("Township Fire Division") desires to recognize Brian D. Sutton, Sr. a Hamilton Township firefighter who died in the line of duty on November 8, 1994; and

Whereas a request has been made by the Hamilton Township Fire Division, FMBA Local 84 and FMBA Local 284 to commemorate the thirtieth anniversary of the death of Firefighter Brian D. Sutton, Sr. to rename a certain roadway located in the Township which is presently known as "Olivia Avenue", with a road length of approximately 240 feet situated to the north of Hamilton Fire Engine 3 and Headquarters to hereafter be known as "Brian Sutton Sr. Way"; and

Whereas the United States Postal Service has consented to the name change; and

*Whereas* the Township Police Division, as well as the Departments of Public Works and Community and Economic Development have reviewed and approved the name change; and

Whereas the Council of the Township of Hamilton is supportive of the intent to re-name said roadway;

*Now, Therefore, Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that a certain roadway located in the Township which is presently known as "Olivia Avenue", with a road length of approximately 240 feet situated to the north of Hamilton Fire Engine 3 and Headquarters to hereafter be known as "Brian Sutton Sr. Way"

Be It Further Ordained that hereafter on any maps or other documents on which the aforesaid roadway is shown, that it shall be identified by the new name of "Brian Sutton Sr. Way".
