

**ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING, § 485-19, HANDICAPPED PARKING (Repealing spaces established at 29 Adella Avenue by Ordinance No. 17-020; 645 Berg Avenue by Ordinance No. 20-046; 816 S. Olden Avenue by Ordinance 14-033; 833 William Street by Ordinance 10-033)**

*Whereas* the Township of Hamilton, in the County of Mercer has received requests to repeal certain handicapped parking spaces that were established on streets for private residences;

*Now, Therefore, Be It Ordained* by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the *Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II, Parking, § 485-19, Handicapped Parking*, as amended and supplemented, be further amended and supplemented as follows:

**Chapter 485**

**VEHICLES AND TRAFFIC**

**Article II – Parking**

**§ 485-19. Handicapped parking.**

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.



Street	Location
[29 Adella Avenue Hamilton, New Jersey 08609]	[Beginning at a point 134 feet west of the curb line of Rosalia Avenue and extending to a point 154 feet west of the curb line of Rosalia Avenue on the south curb of Adella Avenue.]
[645 Berg Avenue Hamilton, New Jersey 08610]	[Beginning at a point 160 feet north of E. Park Avenue and extending to a point 182 feet north of E. Park Avenue along the west bound curb line of Berg Avenue.]
[816 South Olden Avenue Hamilton, New Jersey 08610]	[Beginning at a point 117 feet south of the curb line of Liberty Street and extending to a point 135 feet south of the curb line of Liberty Street on the east curb of South Olden Avenue.]
[833 William Street Hamilton, New Jersey 08610]	[Beginning at a point 191 feet south of the curb line of Cedar Lane and extending to a point 213 feet of the curb line of William Street.]

Any Ordinance or Ordinances in conflict with the provisions of this Ordinance are repealed to the extent of such conflict.


