



ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF HAMILTON, NEW JERSEY, CHAPTER 485, VEHICLES AND TRAFFIC, ARTICLE II, PARKING; § 485-19, HANDICAPPED PARKING (Establishing spaces for 29 McClellan Avenue and 110 Tindall Avenue)

Whereas the Township of Hamilton, in the County of Mercer has received requests to establish handicapped parking spaces on streets for private residences;

Now, Therefore, Be It Ordained by the Council of the Township of Hamilton, in the County of Mercer and State of New Jersey, that the Code of Ordinances of Hamilton Township, New Jersey, Chapter 485, Vehicles and Traffic, Article II; Parking, § 485-19, Handicapped Parking, as amended and supplemented, be further amended and supplemented as follows:

Chapter 485

VEHICLES AND TRAFFIC

Article II – Parking

§ 485-19. Handicapped parking.

- B. Handicapped parking on streets for private residences. In accordance with the provisions of N.J.S.A. 39:4-197.6, the following on-street locations are designated as handicapped parking spaces in front of private residences occupied by handicapped persons. Such spaces are for use by persons who have been issued special identification cards or plates or placards by the Motor Vehicle Commission or a temporary placard issued by the Chief of Police. No other person shall be permitted in these spaces.

Street	Location
<u>29 McClellan Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 69 feet west of Sewell Avenue and extending to a point 88 feet west of Sewell Avenue, along the south side curb line of McClellan Avenue in front of the residence.</u>
<u>110 Tindall Avenue</u> <u>Hamilton, New Jersey 08610</u>	<u>Beginning at a point 88 feet east of Hutchinson Street and extending to a point 102 feet east of Hutchinson Street, along the north side curb line of East Franklin Street, in front of 114 Tindall Avenue.</u>
