

**BOROUGH OF HALEDON
ORDINANCE NO.7-13-2023**

**AN ORDINANCE OF THE MUNICIPAL COUNCIL OF THE BOROUGH
OF HALEDON, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY,
TO AMEND CHAPTER 205 (VEHICLES AND TRAFFIC)
OF THE CODE OF THE BOROUGH OF HALEDON**

WHEREAS, under N.J.S.A. 39:4-197, a municipal may enact ordinances to designate certain parking areas on roadways under municipal control for use by person who have been issued special vehicle identification cards by the New Jersey Division of Motor Vehicles,

WHEREAS, it is necessary to update and amend the Municipal Code to include additional parking areas on roadways and to remove those which are no longer necessary to serve the needs of the persons identified herein; and

WHEREAS, the Municipal Council has found it proper to amend the language of the Code accordance therewith;

NOW THEREFORE BE IT RESOLVED by the Municipal Council of the Borough of Haledon, that Chapter 205, Vehicles and Traffic, of the Code of the Borough of Haledon, is hereby amended and supplemented as follows (underlined to be added, ~~struck through~~ is deleted):

§205-19 Restriction of Spaces.

A. Residential locations.

Name of Street	Location
<u>88 Avenue B</u>	<u>From the Northwest corner of Avenue B and Albion Avenue one hundred two (102) feet west on Avenue B then continuing west another twenty-two (22) feet</u>
<u>7 Buschmann Avenue (1st floor)</u>	<u>From the Southwest corner of Belmont Avenue and Buschmann Avenue ninety-five feet (95 feet) west on Buschmann Avenue then continuing West another twenty-two (22) feet</u>
<u>7 Buschmann Avenue (2nd floor)</u>	<u>From the Southwest corner of Belmont Avenue and Buschmann Avenue seventy-six feet (76 feet) west on Buschmann Avenue then continuing West another twenty-two (22) feet</u>

360 Morrissee Avenue

From the northeast corner of Norwood Avenue and Morrissee Avenue extending sixty-eight (68) feet east on Norwood Avenue and then continuing another 22 feet (parking space is on Norwood Avenue side of corner property)


NOW, THEREFORE, BE IT FURTHER ORDAINED that:

1. Ordinances, resolutions and regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistency; and
2. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portion of the Ordinance; and
3. Except as hereby amended, the Code of the Borough of Haledon shall remain in full force and effect.
4. Borough Police Department shall have the authority to place such signs as deemed necessary to advise the public of the parking restrictions or remove such signs to reflect that designation has been removed.
4. This Ordinance shall take effect twenty days after final passage and publication in accordance with law.
