

**BOROUGH OF HALEDON  
ORDINANCE NO. 10-12-2023**

**AN ORDINANCE OF THE MUNICIPAL COUNCIL OF THE BOROUGH  
OF HALEDON, IN THE COUNTY OF PASSAIC, STATE OF NEW JERSEY,  
TO AMEND CHAPTER 205 (VEHICLES AND TRAFFIC)  
OF THE CODE OF THE BOROUGH OF HALEDON**

**WHEREAS**, under N.J.S.A. 39:4-197, a municipal may enact ordinances to designate certain parking areas on roadways under municipal control for use by person who have been issued special vehicle identification cards by the New Jersey Division of Motor Vehicles,

**WHEREAS**, it is necessary to update and amend the Municipal Code to include additional parking areas on roadways and to remove those which are no longer necessary to serve the needs of the persons identified herein; and

**WHEREAS**, the Municipal Council has found it proper to amend the language of the Code accordance therewith;

**NOW THEREFORE BE IT RESOLVED** by the Municipal Council of the Borough of Haledon, that Chapter 205, Vehicles and Traffic, of the Code of the Borough of Haledon, is hereby amended and supplemented as follows (underlined to be added):

**§205-19 Restriction of Spaces.**

**A. Residential locations.**

Name of Street	Location
<u>337 Vandyke Avenue</u>	<u>From the Southwest corner of Norwood Street and Vandyke Avenue Two hundred eighteen (218) feet south on Vandyke Avenue then continuing south another twenty-two (22) feet</u>
<u>10 John Ryle Avenue</u>	<u>From the northwest corner of John Ryle Avenue and Terrace Avenue One hundred four feet (104 feet) west on John Ryle Avenue then continuing West another twenty-two (22) feet</u>
<u>64 Bernard Avenue</u>	<u>From the northeast corner of Bernard Avenue and North 14th Street forty-one feet (41 feet) north on Bernard Avenue then continuing north another twenty-two (22) feet</u>
<u>381 Morrissee Avenue</u>	<u>From the southwest corner of Morrissee Avenue and Tilt Street extending One hundred Ninety-two (192) feet south on Morrissee Avenue and then continuing south another 22 feet</u>

**NOW, THEREFORE, BE IT FURTHER ORDAINED** that:

1. Ordinances, resolutions and regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistency; and
2. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portion of the Ordinance; and

3. Except as hereby amended, the Code of the Borough of Haledon shall remain in full force and effect.

4. Borough Police Department shall have the authority to place such signs as deemed necessary to advise the public of the parking restrictions or remove such signs to reflect that designation has been removed.


4. This Ordinance shall take effect twenty days after final passage and publication in accordance with law.


