ORDINANCE NO. 3-12-2026C

AN ORDINANCE AMENDING CHAPTER 48-36.4 OF THE CODE OF THE BOROUGH OF HALEDON TITLED "POLICE OFFICERS, OFF-DUTY EMPLOYMENT OF – RATES OF COMPENSATION; ADMINISTRATIVE FEE; PAYMENT FOR SERVICES"

WHEREAS, the Borough of Haledon wishes amend the rates charged for Police Officers who are employed while off duty; and

NOW THEREFORE BE IT RESOLVED, by the Governing Body of the Borough of Haledon that Chapter 48-36.4 of the Code of the Borough of Haledon is hereby amended to read as follows (additions underlined, deletions struck through).

The rate of compensation to be paid by private businesses, contractors, and public or quasi-public entities contracting with the Borough for the employment of police officers in the performance of off-duty services shall be as follows:

1. Police Officer Rate shall be ~~\$90.00 per hour~~ **\$100.00 per hour.**
2. Police Officer Rate charged to the Borough of Haledon, Haledon Board of Education, and Manchester Regional High School Board of Education shall be ~~\$70.00 Per Hour~~ **\$75.00 per hour.**
3. Police Unit Rate shall be \$20 per hour.
4. The Administrative Fee shall be ~~\$10.00 per hour~~ **\$20.00 per hour.**

BE IT FURTHER ORDAINED, that all ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed to the extent of any such inconsistency.

BE IT FURTHER ORDAINED, that if any section, paragraph, subdivision, clause, or provision of this ordinance is adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause, or provision so adjudged, and the remainder of this ordinance shall be deemed valid and effective.

BE IT FURTHER ORDAINED, that this ordinance shall take effect upon final passage and publication according to applicable law.
