TOWNSHIP OF HAZLET ORDINANCE NUMBER 1723-23

CAPITAL ORDINANCE PROVIDING FOR INSPECTION AND POLICE VEHICLES, BY AND IN THE TOWNSHIP OF HAZLET, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY; APPROPRIATING \$150,000 THEREFORE FROM THE CAPITAL ACCOUNT TO PAY FOR THE COST THEREOF

WHEREAS, the Township of Hazlet, in the County of Monmouth, State of New Jersey (the "Township"), wishes to undertake Inspection and Police Vehicles in and for the Township; and

WHEREAS, the cost of said Inspection and Police Vehicles is estimated to be \$150,000; and

WHEREAS, the Township desires to authorize the appropriation and expenditure of \$150,000 from the Capital Account of the Township in order to undertake Inspection and Police Vehicles in and for the Township.

BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HAZLET, IN THE COUNTY OF MONMOUTH, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

SECTION 1. The capital improvements or purposes described in Section 2 of this capital ordinance are hereby authorized as general capital improvements to be undertaken by the Township. For the said improvements or purposes stated in Section 2, there is hereby appropriated the amount of \$150,000 from the Capital Account of the Township to undertake Inspection and Police Vehicles in and for the Township.

SECTION 2. The capital improvements or purposes hereby authorized are Inspection and Police Vehicles in and for the Township including, but not limited to acquisition and installation, as applicable, of all materials and equipment, and work, labor and appurtenances necessary therefor or incidental thereto.

SECTION 3. The expenditure of the \$150,000, consisting of an appropriation of \$150,000 from the Capital Account of the Township, for the improvements or purposes set forth in Section 2 hereof is hereby authorized and approved. The Mayor, the Clerk, the Chief Financial Officer and the Administrator of the Township are each hereby authorized and directed to execute, deliver and perform any agreement to undertake the improvement or purpose set forth herein and to effectuate the transactions contemplated hereby.

SECTION 4. The capital budget of the Township is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency herewith and a resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital programs as approved by the Director of the Division of Local Government Services, New Jersey Department of Community Affairs is on file in the office of the Clerk and is available for public inspection.

SECTION 5. This ordinance shall take effect immediately after final adoption and approval by the Mayor as described in N.J.S.A. 40:49-2.
