

Chapter 33 CLEAN AIR or may be a section (whatever is appropriate). This just has to follow Chapter 32 ALCOHOLIC BEVERAGES (it relates to the same concept)

33.1 Purpose

It is the purpose of this Chapter is to reduce the risk of secondhand smoke by implementing the Smoke Free Air Act (SFAA). The SFAA prohibits smoking and the use of electronic cigarettes in most workplaces and public spaces.

33.2 Definitions

Smoking is defined as the inhalation or tasting of any substance, including but not limited to tobacco or cannabis.

A "vape," or electronic cigarette, is a device that heats a liquid to create a vapor that a person inhales.

33.3 Smoking and Vaping in Public Areas Prohibited

It shall be a violation of this chapter for any person to:

- A. Smoke of any product containing tobacco or cannabis and vaping, as identified in 33.2, is prohibited in village public parks, playgrounds, outdoor dining areas and buildings.

33.4 Signs will be posted "No Smoking, Electronic Cigarette, Vaping"

33.5 Penalties for Offenses

Any person, upon conviction for violation of any of the provisions of this chapter, shall be punishable by a fine of not more than \$250 or by imprisonment for not more than 15 days, or both.
