

**ORDINANCE NO. 12-2024**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER AUTHORIZING THE RESURFACING OF A PORTION OF BEE MEADOW PARKWAY FROM PARSIPPANY ROAD TO FENWICK ROAD IN THE WHIPPANY SECTION OF THE TOWNSHIP AND APPROPRIATING THE SUM OF \$174,840.00 FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION'S FISCAL YEAR 2023 MUNICIPAL AID PROGRAM AND \$175,160.00 FROM THE TOWNSHIP'S 2024 CURRENT FUND BUDGET**

**WHEREAS**, it is the intention of the Township of Hanover to resurface a portion of Bee Meadow Parkway from ParsIPPany Road to Fenwick Road in the Whippany Section of the Township of Hanover; and

**WHEREAS**, due to its deteriorating condition, it is essential to ensure the safety of motorists and pedestrians, and in this respect, it is the desire of the Township Committee to authorize this improvement to this roadway which is a main east-west artery; and

**WHEREAS**, in 2023, the Township was informed by the New Jersey Department of Transportation (NJDOT) that the Township will receive a \$174,840.00.00 grant through the NJDOT's Fiscal Year 2023 Municipal Aid Program to help underwrite a portion of the total cost to resurface a portion of Bee Meadow Parkway; and

**WHEREAS**, funds for the resurfacing of a portion of Bee Meadow Parkway are available through the Road Construction and Reconstruction Account of the Township's Calendar Year 2024 Current Fund Budget, and a grant from the NJDOT's Fiscal Year 2023 Municipal Aid Program; and

**WHEREAS**, the resurfacing of a portion of Bee Meadow Parkway will include milling, a new asphalt riding surface, drainage modifications and other related improvements as detailed in the Township's Construction Plan, Specification and Supplementary Specification, and in accordance with the NJDOT's 2019 Standard Specifications as amended by the 2019 Special Provisions for State Aid Projects.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

**Section 1.** The governing body hereby authorizes the resurfacing of a portion of Bee Meadow Parkway from Parsippany Road to Fenwick Road in the Whippany Section of the Township. The resurfacing project shall include milling, a new asphalt riding surface, drainage modifications and other related improvements.


**Section 2.** The Township Engineer and Assistant Township Engineer are further authorized and directed to prepare the construction plan, specification and supplementary specification to be utilized in connection with the resurfacing of a portion of Bee Meadow Parkway as described in **Section 1.** above and to publicly advertise and receive sealed competitive bids all in accordance with the Local Public Contracts Law at N.J.S.A. 40A:11-1. et seq.

**Section 3.** There is hereby appropriated the sum of \$350,000.00 to undertake the resurfacing of a portion of Bee Meadow Parkway as described in **Section 1.** of this Ordinance from the following accounts:


