## **ORDINANCE NO. 19-2024**

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE PHASE II RENOVATION AND IMPROVEMENT TO THE MAIN PUBLIC MEETING ROOM AND CONFERENCE ROOMS AT THE MUNICIPAL BUILDING TO INCLUDE NEW CHAIRS AND FURNITURE AND FURTHER APPROPRIATING THE SUM OF \$100,000.00 FROM THE 2024 CAPITAL IMPROVEMENT FUND AND ALL PRIOR YEARS FOR THE FINANCING OF THE PHASE II PROJECT

**WHEREAS**, pursuant to Capital Improvement Ordinance No. 23-2023, the Township authorized implementation of the first phase renovation and improvement to the main, public meeting room with the installation of a new, integrated audio and video system to replace the current system that has outlived its useful purpose; and

**WHEREAS**, originally, the second phase of the project was to include the creation of a two-tier main, public meeting room dias, new chairs, furniture, carpeting, and painting as well as new chairs and furniture for the two adjoining conference rooms, all under a Phase II; and

**WHEREAS**, because of 2024 budgetary constraints, Phase II of the project has been modified to only include new chairs and furniture for the main, public meeting room and the two conference rooms.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:

**SECTION 1.** The governing body hereby authorizes the acquisition, purchase and installation of new chairs and furniture for the main, public meeting room and the two adjoining conference rooms to include all labor, materials and related appurtenances under a modified Phase II renovation and improvement project.

**SECTION 2.** As set forth in Ordinance No. 23-2023, the firms of Clarke, Caton, Hintz and the Princeton Engineering Group, whose members are licensed by the State of New Jersey as professional architects, planners and engineers respectively, will continue to provide professional consultant services for the Phase II project.

**SECTION 3.** For the acquisition, purchase and installation of new chairs and furniture including all related appurtenances as described in **Section 1**. above, the governing body authorizes the Department of Administration to publicly advertise for the receipt of sealed competitive bids, pursuant to the Local Public Contracts Law, N.J.S.A. 40A: 11-1 et. seq., or utilizing the procurement services through an approved Cooperative Pricing System, at N.J.A.C. 34-7.4 et seq., authorized by the State of New Jersey, or, through a National Cooperative Purchasing Program authorized in accordance with N.J.S.A. 52: 34-6.2(3), or through a valid and current State Contract approved by the Cooperative Purchasing Program of the Division of Purchase and

Property in the Department of the Treasury, all in accordance with N.J.S.A. 40A: 11-12.a. and N.J.A.C. 5: 34-7.29c.

**SECTION 4.** For the financing of the Phase II project described in **Section 1**., there is hereby appropriated the sum of \$100,000.00 from the 2024 Capital Improvement Fund and all prior years including the unallocated portion of the Capital Improvement Fund, if necessary.

<u>SECTION 5.</u> In case for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid, the same shall not affect any other section or provision of this Ordinance, except so far as the section or provision so declared unconstitutional or invalid shall be severed from the remainder or any portion thereof.

**SECTION** 6. All ordinances or parts of ordinances inconsistent with the provisions of this Ordinance are, to the extent of such inconsistency, thereby repealed.

**SECTION 7.** This Ordinance shall take effect in accordance with law.
