

**ORDINANCE NO. 22-2024**

**AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AUTHORIZING THE REPLACEMENT OF THE CHLORINE TANK IN THE MAIN POOL PUMP ROOM AT THE BEE MEADOW SWIMMING POOL FACILITY AND FURTHER APPROPRIATING THE SUM OF \$50,000.00 FROM THE SWIMMING POOL ENTERPRISE FUND – CAPITAL ACCOUNT FOR 2024 AND ALL PRIOR YEARS FOR THE FINANCING OF THE PROJECT**

**WHEREAS**, the existing chlorine tank in the main pool pump room installed circa 1991 has outlived it's useful purpose and has developed a leak; and

**WHEREAS**, the Hanover Township Board of Recreation Commissioners has included in its 2024 Capital Budget certain improvements and amenities to the Bee Meadow Swimming Pool facility including replacement of the existing chlorine tank; and

**WHEREAS**, the Township Committee has reviewed the proposed project and concurs with the Board of Recreation Commissioners that the continual maintenance and improvement to the Bee Meadow Swimming Pool is essential in order to maintain its integrity and reliability as a fully functional and operational amenity for the benefit of Pool members.

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Hanover, in the County of Morris and State of New Jersey as follows:

**Section 1.** The governing body hereby authorizes and approves the purchase and installation of a new chlorine tank to replace the existing chlorine tank at the Bee Meadow Swimming Pool facility located at Bee Meadow Park.

**Section 2.** The Township Engineer and/or the Assistant Township Engineer are authorized and directed to retain the services of a licensed professional engineer in order to prepare the necessary plans and specifications for the chlorine tank replacement.

**Section 3.** Following the preparation of the engineering documents, the Engineering Department, in accordance with Local Public Contracts Law at

N.J.S.A. 40A:11-1 et seq., shall obtain at least two written quotations for the project described in **Section 1.** above.

**Section 4.** The Township Committee hereby appropriates the sum of \$50,000.00 from the 2024 Swimming Pool Enterprise Fund – Capital Account and all prior years for the purchase and installation of all equipment, materials and hardware related to the project described in **Section 1.** of this Ordinance and also for retaining the services of a licensed professional engineer in preparing the plans and specifications required by the Township’s Building Department and Health Department related to the purchase and installation of the project.

**Section 5.** This Ordinance shall take effect in accordance with the law.
