AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HANOVER IN THE COUNTY OF MORRIS AND STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING SWIMMING POOL ENTERPRISE FUND (SPEF) ORDINANCE NO. 14-2023 AUTHORIZING THE REPLACEMENT OF THE STARTING BLOCKS AT THE BEE MEADOW SWIMMING POOL AND FURTHER APPROPRIATING AN ADDITIONAL SUM OF \$10,000.00 FROM THE SWIMMING POOL ENTERPRISE FUND – CAPITAL ACCOUNT FOR 2024 AND ALL PRIOR YEARS FOR THE FINANCING OF THE PROJECT

WHEREAS, on April 13, 2023, the Township Committee adopted Ordinance No. 14-2023 which authorized the resetting of the starting blocks at the Bee Meadow Swimming Pool and further appropriated the sum of \$17,000.00 from the Swimming Pool Enterprise Fund's Capital Account for 2023 and all prior years for the project; and

WHEREAS, based on an assessment conducted by the Recreation and Park Administration Department it was determined that the starting blocks used by the Recreation Department's Swim Team needed to be replaced rather than reset; and

WHEREAS, the cost to replace the starting blocks exceeded the original appropriation for consultant services and the resetting of the blocks which necessitated a supplemental appropriation; and

WHEREAS, on April 11, 2024, the Township Committee adopted Ordinance No. 6-2024 which transferred \$23,000 from Ordinance No. 18-2023 to Ordinance No. 14-2023 in order to supplement funding for the replacement of the starting blocks; and

WHEREAS, the cost to replace the starting blocks requires a supplemental appropriation based on the revised design plans and current material and labor costs.


NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Hanover in the County of Morris and State of New Jersey as follows:
