 AN ORDINANCE AMENDING ORDINANCE NO. 23-08
 FIXING THE SALARIES AND WAGES
 OF TOWNSHIP OFFICIALS AND EMPLOYEES OF THE
 TOWNSHIP OF HARMONY, COUNTY OF WARREN AND
 STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Harmony, in the County of Warren and State of New Jersey:
