#### **ORDINANCE NUMBER 2557**

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 133 OF THE CODE OF THE BOROUGH OF HASBROUCK HEIGHTS AND, SPECIFICALLY, TO AMEND SECTION 133-21.1 ENTITLED "FEES UNDER CHAPTER 181, MOTOR VEHICLE SALES."

**WHEREAS,** Chapter 133 of the Code of the Borough of Hasbrouck Heights controls and regulates fees charged by the Borough; and

WHEREAS, Section 133-21.1 of the Borough Code entitled "Fees, under Chapter 181, Motor Vehicle Sales," states the fees charged for licenses and applications in connection with the sale of motor vehicles; and

**WHEREAS**, the Mayor and Council of the Borough of Hasbrouck Heights has determined that it is in the best interest of the Borough to update these fees.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF HASBROUCK HEIGHTS, COUNTY OF BERGEN, AND STATE OF NEW JERSEY, AS FOLLOWS:

## **SECTION ONE:**

Section 133-21.1 of the Code of the Borough of Hasbrouck Heights is amended as follows:

#### A. Fees

- (1) Annual license application fee: \$2,000, which shall include all applications regardless of when the same is sought during the term of such license.
- (2) Application fee upon late application for renewal: \$350 for each month or any portion thereof following the expiration of the term of a license for which renewal is sought.
- (3) Application for reinstatement following revocation: \$2,000.
- (4) Appeal to governing body: \$750.

# **SECTION TWO**. Repealer:

All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency only.

## **SECTION THREE:** Severability:

If any section, subsection, paragraph, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair or invalidate the remainder of this Ordinance, but shall be confined in its effects to the section, subsection, paragraph, sentence or other part of this Ordinance directly involved in the controversy in which said judgment shall have been rendered and all other provisions of this Ordinance shall remain in full force and effect.

## **SECTION FOUR:** Effective Date:

This Ordinance shall take effect immediately upon final adoption and publication and in the manner provided by law.
