A Resolution ratifying the submission of a grant application to the Pennsylvania Department of Community and Economic Development's Greenways, Trails and Recreation Program for \$117,228 for the purpose of constructing a multipurpose pavilion in Riverfront Park.

WHEREAS, the City of Harrisburg (the "City") desires to apply for this grant to fund the construction of a multipurpose, open-sided 24x20 pavilion in Riverfront Park adjacent to the Civic Club Building near Front and Liberty Streets (the "Project"); and

WHEREAS, the Project will allow the City to bring a variety of programming and new events to the Downtown area which will help further drive tourism and economic development in the City; and

WHEREAS, the grant requires a fifteen percent (15%) local match; and

WHEREAS, the City will utilize funds in the Special Events Fund to provide the local match; and

WHEREAS, the City's application is attached hereto as "Exhibit A."

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE COUNCIL OF THE CITY OF HARRISBURG, that submission of a grant application to the Department of Community and Economic Development's Greenways, Trails, and Recreation Program for the purpose of constructing a multipurpose pavilion in Riverfront Park is ratified.

What do you plan to accomplish with this project?

This project will construct a permanent bandshell at 600 N Front Street in Riverfront Park in Harrisburg. Riverfront Park is one of the most heavily used and well-known parks in the City. It hosts events of all sizes throughout the year that attract residents and tourists alike. Riverfront Park is the only park in the Downtown area and does not currently have any pavilions, limiting the full potential of the space and hampering the City's ability to support of the robust and growing Downtown community. Adding a multipurpose pavilion that can act as a stage and gathering place for events and programs held by the Parks & Rec Department, residents, and other City organizations, would be a tremendous asset to the City and the community. It would also have significant financial benefits, saving the City's Special Events team over \$17,500 annually in renting stages, and providing an additional revenue stream for the Parks Department through external rentals.

How do you plan to accomplish it?

City will RFP for a vendor that can supply and install the required equipment. City currently has quotes from Kompan; Recreation Resource USA; MRC; and CRS, Inc. We have based our budget and budget narrative on the Kompan quote. We are glad to share the other quotes with DCED analysts at any time if helpful.

How do you plan to use the funds?

City would use grant funds to construct a permanent band shell at 600 N Front Street in Riverfront Park in Harrisburg. This stage would be utilized by Parks and Rec for several programs such as Yoga in the Park, Sip and Paint events, and movie nights. Due to its layout and walkability, events such as Kids to Parks Day, magic lessons/shows, and candle making would greatly benefit from the bandshell venue we propose. A stage in this location would allow Parks and Rec to bring new events to the community: comedy shows, karaoke/poetry nights, concerts and more! Parks and Rec has stages in Res Park and Italian Lake, N Front Street would be optimal for events, because the location is close to many residents who mainly walk to events and cannot access other stages. Its proximity to City Island makes parking easier for those who drive. This would also be a great space for the community partners to host some of their annual events, like the summer concert series, or Shakespeare in the Park.

Projected Schedule and Key Milestones and Dates

The City of Harrisburg is requesting funds from the DCED GTRP grant program to construct a multipurpose pavilion in Riverfront Park. The City commits to providing a 15% match of the overall Project Cost from the Events Fund for the project. The project proposes construction of an open-sided 24x20 pavilion with a concrete base. The design will be minimal to complement the surrounding environment and natural beauty of the park. It will be positioned within Riverfront Park, at 600 N Front Street, adjacent to the Civic Club Building, near Liberty Street.

The pavilion would be the first and only pavilion within Riverfront Park, which spans nearly 4 miles alongside the Capital Area Greenbelt and Susquehanna River. It is the City's only park in the Downtown area. In addition to being a hub for restaurants, shopping, and other businesses, Riverfront Park is frequented daily by an increasing number of Harrisburg residents. According to the State of Downtown Harrisburg report released by Harristown Enterprises in 2023, "development in the Downtown area has exploded over the last 5 years. There are over 1,500 residential units Downtown, over 30,000 employees in the Downtown workforce, and over 5,000 students that study at Harrisburg University located Downtown." The addition of a pavilion that is easily accessible to these residents and workplaces for birthday parties, picnics, special events, and more, is essential to supporting the continued economic and cultural growth of the Downtown area.

The pavilion will allow the City's Parks & Recreation Department to bring a variety of programming to the Downtown area, such as fitness classes, art and craft workshops, first aid and safety lessons, movie nights, and more. It would also allow the City to bring new events to the Downtown community, such as comedy shows, poetry nights, concerts, and more. The pavilion would be very walkable for both the Downtown and Midtown communities, and it is within close proximity to the City Island parking lot and River Street parking garage for those who prefer to drive. Being located next to the Civic Club of Harrisburg, both the City and the Civic Club agree that the pavilion will serve as the perfect complement to the Club's indoor reception space for couples seeking a large outdoor ceremony space. External rentals of the pavilion for weddings and other events will bring in revenue for the City's Parks Department, which will contribute to the long-term financial stability of the entire Harrisburg Parks system.

The City's Special Events Department would also benefit greatly from the addition of a pavilion in this space. The Department currently hosts 3 large scale summer festivals spanning a total of 7 days, for which it typically pays about \$17,500-\$21,000 annually to rent stages. Having a built-in pavilion to serve as a stage for these events would be a tremendous financial benefit. The City routinely attracts interest from 3rd parties interested in bringing similar large-scale events to the City, and the addition of a pavilion would help sell the space as the perfect venue, helping to further drive tourism and economic development in the City.

The City of Harrisburg intends to apply for DCED GTRP grant funds in the amount of \$117,228 to help fund the installation of a permanent multipurpose bandshell in north Riverfront Park. The project proposes construction of an open-sided 24x20 pavilion with a concrete base. The design will be minimal and will complement the surrounding environment and natural beauty of the park. It will be positioned within Riverfront Park, at 600 N Front Street, adjacent to the Civic Club Building, near Liberty Street.

The expected overall cost for this project is \$138,406. The City commits to providing a 15% match of the overall Project Cost from the City's Special Events Fund for the project. Given the limits of what the City may ask in terms of one of the project's budget line items—Installation costs (10% only from the grant)—we anticipate that the City's match will be \$21,178, which is slightly above the 15% match requirement, but it is the amount that City must supply to make the budget whole. We are prepared to supply this amount from the City's Special Events budget.

Courtney:

This letter is in response to a request for a letter certifying that the project referenced above is in compliance with the comprehensive planning of the City of Harrisburg. While the project is fairly conceptual at this point, it involves the construction of an open-sided performance pavilion with a minimal profile to complement the viewsheds and beauty of Riverfront Park. While an exact location has not been determined, it will be located in the area just south of the Harrisburg Civic Club at 612 North Front Street. Establishing a permanent location to facilitate cultural celebrations such as ArtsFest and Kipona will reduce the cost of temporary set-ups for such events and provide a year-round location for residents and visitors to host musical, cultural, or artistic festivities.

The City's Comprehensive Plan addresses investment in Harrisburg's parks and recreation infrastructure through the "Parks, Open & Civic Spaces" chapters. The proposed projects would conform to the following Goals, Objectives, and Action Items in that chapter:

- Goal POC-2: Enhance the "Riverfront Destination" experience;
- Objective POC-2.4: Program more activities in Riverfront Park, including festivals, concerts, and races; and
- POC.5: Identify and promote new amenities (i.e. barges, docks, refreshment kiosks, etc.) to connect residents and visitors to the Susquehanna River.

Because new permanent installations within areas of Riverfront Park located in Municipal Historic Districts fall under the purview of the Historic Architectural Review Board (HARB), the final design of the proposed pavilion/stage has not been determined. The facility should take design cues from other plazas and structures within Riverfront Park, such as the Old Waterworks Building, the Civic Club, and Kunkel Plaza to ensure it integrates within the cultural landscape. The project also offers the opportunity to plan the surrounding area for the benefit of and enjoyment by the public by removing illegal parking which has ruined this section of the park and creating a space where residents, visitors, and workers can enjoy the natural beauty and serenity of this riverside overlook.

This project will introduce a unique amenity to Riverfront Park, enhancing the experience for all park users and creating a hub for art, culture, and tourism. Given the above, and in anticipation of further collaboration between City departments and the general public, the Planning Bureau can confirm that the objectives of the project align with the goals of the Comprehensive Plan.
