§ 160-58 District extension fee.

:

A. Each unit will be subject to a minimum per unit fee set by Town Board resolution, which is to be paid in full for all EDUs prior to final stamping of plans unless otherwise agreed to by the Town (see § 160-60 for water system assessment schedule). The Town shall have the authority to exempt any unit from the fee set by the Town Board so long as the application involves four or less EDUs within a two-year period.
