

ORDINANCE NO. 871 - 2023

AN ORDINANCE FOR THE BOROUGH OF HAMBURG, COUNTY OF BERKS, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE ON ALL REAL PROPERTY LOCATED WITHIN THE BOROUGH OF HAMBURG FOR THE YEAR 2024 AT 8.50 MILLS FOR GENERAL PURPOSES AND 0.50 MILLS FOR FIRE PROTECTION SERVICES.

BE IT, and it is hereby enacted and ordained by the Borough Council of the Borough of Hamburg, Berks County, Pennsylvania, as follows:

SECTION 1. 2024 Tax Rate.

That a tax be and the same is hereby levied on all real property within the Borough of Hamburg subject to taxation for the fiscal year of 2024, as follows:

The tax rate for general purposes is 8.50 mills on each dollar of assessed valuation.

The tax rate for fire protection services is 0.50 mills on each dollar of assessed valuation.

The total tax rate for all purposes is 9.00 mills on each dollar of assessed valuation.

SECTION 2. Tax Revenue Appropriations.

With respect to the expenses for the fiscal year of 2024, the following amounts are hereby appropriated from the tax revenues available for the specific purposes set forth below:

Total Anticipated Receipts (including fire), General Operating Fund	\$5,112,175.00
Total Appropriations, General Operating Fund	\$5,112,175.00

These amounts are more fully itemized in the budget form.

SECTION 3. Public Inspection.

An estimate of the specific items making up the amounts appropriated to the respective Departments of the Borough is on file in the municipal office of the Borough of Hamburg, Pennsylvania located at 61 North 3rd Street, Hamburg, Pennsylvania.

SECTION 4. Repeal of Ordinances.

Any ordinance, parts of ordinances, resolution or parts of resolutions conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance's provisions.

SECTION 5. Severability.

If any article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase or word in this Ordinance, is, for any reason declared to be illegal, unconstitutional or invalid, by any Court of competent jurisdiction, this decision shall not affect or impair the validity of the Ordinance as a whole, or any other article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase, word, or remaining portion of the within Ordinance. The Borough Council of the Borough of Hamburg, Pennsylvania, hereby declares that it would have adopted the within Ordinance and each article, section, subsection, provision, regulation, limitation, restriction, sentence, clause, phrase and word thereof, irrespective of the limitations, restrictions, sentences, clauses, phrases, or word that may be declared illegal, unconstitutional or invalid.

SECTION 6. Effective Date.

This Ordinance shall become effective at the earliest date permitted by law but no later than January 1, 2024.
