**ORDINANCE NO. 2017**

**AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF HARRISON TOWNSHIP, ALLEGHENY COUNTY, COMMONWEALTH OF PENNSYLVANIA, APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT, HERINAFTER SET FORTH, DURING THE FISCAL YEAR 2024.**

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Commissioners of Harrison Township, Allegheny County, Pennsylvania:

SECTION 1. That for the expenditures of the fiscal year 2024, the following amount are hereby appropriated from the resources available for the current fiscal year for the specific purposes set forth below, in accordance with Generally Accepted Accounting Principles, cash bases of accounting:




