RESOLUTION #13-206/2024 To update the 2024 Dog Control Fee Schedule (formerly known as the Animal Control Fee Schedule).

WHEREAS, the fees for veterinary services for dogs that have been seized by Dog Control have increased, therefore the Town would like to adjust our Fee Schedule to reflect those changes; and

WHEREAS, to better deal with those individuals who repeatedly allow their dogs to escape while not creating hardship for the individuals who inadvertently allow their dogs to escape one time, the Town would like to adjust the schedule to keep the cost down for first time escapes by making it per incident such that multiple dogs escaping in a single incident does not escalate to the higher incident rates; and

WHEREAS, some of the wording of the current fee schedule was not always clear; and

WHEREAS, the Dog Control Officer is only authorized to handle dogs, so it is unnecessary to list any other animal fees.

THEREFORE, BE IT RESOLVED, that the "§ A301-1. Animal Control Fee Schedule" be updated to now be referenced as "§ A301-1. Dog Control Fee Schedule".

BE IT FURTHER RESOLVED, that the "§ A301-1. Dog Control Fee Schedule" reflect this new pricing and improved clarity of the schedule itself, as per the attached fee schedule.
